For your safety and comfort the pool is inspected, cleaned and if necessary, chemically balanced every week. The pool staff do not need to gain access to the interior of the villa to carry out this maintenance. On rare occasions it may be necessary to apply extra chemicals to the pool to maintain safe and correct chemical levels. Should this occur during your stay it may be necessary for all guests to refrain from using the pool for a period specified by the pool cleaning company's agent - this is a normal part of pool maintenance and is for your comfort and safety.

If the pool heater cannot reach optimum temperature due to adverse cold weather conditions the owners or the management company cannot accept responsibility.

Should you have any special requirements, we will endeavour to meet your needs, however, certain requests may incur additional charges and certain requests may unfortunately, be unavailable. The use of the villa and amenities including the pool is entirely at your own risk. Children must be supervised by a responsible adult at all times whilst in and around the pool area.

The owners and the management company of the property accept no responsibility whatsoever for death, personal injury, accidents, loss or damage to persons or personal belongings howsoever caused by any reason or for any claim made as a result of this booking and/or the subsequent holiday/vacation. You are responsible for taking out your own insurance policy to cover all risks. This waiver is also applicable to people visiting the property as your guests.

The owners will not accept any liability for injury or death, damage or loss caused, or for any such claim by a third party as a consequence of actions by you and other people occupying the property during the rental period.

The owners cannot accept any liability for any loss of rental time due to travel problems, flight delays or cancellations or any events outside their control, including any form of Force Majeure.

The owners and the management company can accept no responsibility for, building works or maintenance within the vicinity of the property, for the sudden failure of villa equipment but will take reasonable immediate action to rectify any such failure upon notification by you the guests. The villa is fully cleaned and prepared between lets, however should extra cleaning be required over and above the norm, we reserve the right to deduct the cost of this from your security deposit.
